**ABSTRACT:** Sarat Chandra Chattopadhyay is the author of the Bengali romantic book Devdas (Bengali:, transliterated as Debdas). Devdas, an archetypal lover in viraha (separation), Paro, his forbidden childhood love, and Chandramukhi, a reformed prostitute, form a tragic triangle at the centre of the narrative. There have been 20 film adaptations of Devdas and 5 single song adaptations.

#### About the Author and the Novel

Saratchandra Chattopadhyay was born on September 15, 1876 in Devanandapur, West Bengal's Hooghly district. Motilal Chattopadhyay was his father, and Bhubanmohini was his mother. Saratchandra spent the most of his youth with his mother in Bhagalpur, Bihar, where he passed the University Entrance Examination. He also attended college for nearly two years but was unable to complete his education. He moved to Burma at the age of 27 and got work as a clerk in a government office in Rangoon. In 1916, he left Rangoon and lived in Baje Shibpur, Howrah, near Kolkata. He subsequently moved to his own residence in Samtabed, a village on the banks of the Rupnarayan, around ten years later. He had built another residence in Kolkata some time before his demise. He died on January 16, 1938, in Kolkata. In 1903, he wrote his first short story and had it published under his uncle Surendranath Ganguli's name. In 1907, Baradidi, a novella or longer short tale, was published in Bharati under his own name. He continued editing the early draughts of several of his works that he had originally written in Bhagalpur when he was in Burma, and he also worked on new fiction. In fact, he modelled some of his most lovable characters—such as "Indranath" of Srikanta (1917) and "Lalu" of Chhelebelar Galpa—on either his friend Rajendranath Majumdar or Raju of Bhagalpur, who passed away three months after he did in 1938.

Saratchandra's renown has been well-established since 1913, especially after 1916. Since then, he has written books that are quite well-known. His books include Devdas, which was written in 1901 but published in 1917, Parineeta, Biraj Bou, Palli-Samaj, Srikanta (published in four parts in 1917, 1918, 1927, and 1933), Charitraheen, Grihadaha, Pather-Dabi, Shesh Prashno, and Bipradas. Numerous Indian languages have received translations of Saratchandra's writings. Numerous of these have also been effectively adapted for the big screen and theatre. One of the best authors to have written on current women in Indian literature is Sarat Chandra. Paro from Devdas (1917), Vijaya from Datta (1917–1919), Hemangini from Mejdidi, and Kamala from Shesh Prashna (1929) are a few of his well-known female characters. Additionally, he published pieces that were included in the anthologies Narir Mulya (1923) and Svadesh O Sahitya (1932). His most well-known works include Shrikanta, Charitrahin, Devdas, Grihadaha, Dena-Paona, and Pather Dabi. The British Government forbade Pather Dabi because of its revolutionary tone. Chhelebelar Galpa, Shubhada (1938), Sheser Parichay (1939), Sharat Chandrer Granthabali (1948), and Sharat Chandrer Aprakashita Rachanabali (1951) are among his posthumous writings

The sad story of Devdas by Saratchandra Chattopadhyay has come to represent an intense, passionate love that is not realised. Devdas and Paro, who were childhood sweethearts who were split apart when Devdas was sent to Calcutta by his father, the local zamindar, are the main characters in this tale. Paro proposes to Devdas when he returns to his hometown as an attractive young man of nineteen. Devdas, however, is unable to overcome parental objections to the relationship and declines the offer. Paro, who is shocked, decides to wed an elderly widower. Devdas leaves for Calcutta, but his thoughts are now consumed by Paro and his unmet love for her. He rushes to Paro, who is now married, and begs her to elope with him, but she declines. He is desperate to find a solution to the problem.

He turns to booze and the courtesan Chandramukhi for comfort after experiencing heartbreak. Even when Chandramukhi falls in love with Devdas, he cannot help but think of Paro at all times. He must now continue
