MEDICAL REIMBURSEMENT RULES BY KOTAK SECURITIES: Only medical expenses incurred for yourself, your spouse, your children, or completely dependent parents and siblings can be claimed for tax exemptions. Bills for such reimbursements can relate to medicines bought from pharmacies or any treatment undergone at any clinic, private or public hospital. You can submit these bills only with your employer. You won't be able to claim any such reimbursements when you file your income tax returns.

A standard deduction of Rs 40,000 has been re-introduced in financial year 2018-19. If you have any tax exemptions under medical bills plus transport allowances, you can claim them under these new deductions. What's better is that you will not need to submit any medical bills to your employer to claim this benefit.
